Variable Tuition Program and FACTS Grant and Aid Assessment

The commitment to a variable tuition program directly stems from the corporate conviction “that a child from a Christian home not be denied a Christ-centered education solely on the basis of family income” (Galatians 6:10; Romans 15:1; I John 3:17). The primary purpose of the RCS Variable Tuition Program is to provide, as much as possible, tuition assistance to those families who, without such assistance, would be unable to send their children to RCS.

The school’s variable tuition program has partnered with a third party, FACTS Grant and Aid Assessment, to provide an equitable and practical way for each family to apply for variable tuition.

Because most of the money available for variable tuition comes from the school’s general budget, Riverside has policy that families can apply for up to 50% of the tuition. Registration, fees, and incidentals are the responsibility of each family.

Current families applying for variable tuition, please remember all service hours for the current year must be completed before variable tuition consideration.
